- Joe Kelly, Big Bear City opposed this measure being on the ballot as it is now. Opposed to a Mello-Roos tax.
- Annette Karnes, Big Bear Lake stated that \$.67 per square foot sounds high for new development. This is a deterrent for development. \$78 per bedroom seems high for vacation rentals. She is concerned about properties going under ground because they don't want to pay fees.

# FA9. Resolution Declaring Intention to Form a Community Facilities District

Board consideration of adopting Resolution No. BBFA2019-006 declaring its intention to establish the Big Bear Fire Authority Community Facilities District No. 2019-1 to authorize the levy of special taxes to finance fire suppression and, emergency medical services for the Big Bear Fire Authority.

Staff, Legal Counsel Lutfi Kharuf, and Consultant Andrea Roess responded to questions from board members. Board members provided comment.

At the hour of 6:59 p.m. Director Putz left the meeting and returned at 7:00 p.m.

Members of the public spoke regarding the proposed Community Facilities District.

- Joe Kelly, Big Bear City stated there is no guarantee that if the CFD is approved that the proposed TOT within the City of Big Bear Lake will pass. What is the dollar amount to quality for exemptions for low-income seniors and disabled persons. There is a parcel tax on every parcel in Big Bear City of \$157 for the fire department. There is also a property tax. This is triple taxation.
  - Director Green provided the low-income qualifying numbers.
- Edward Stanik, Big Bear City questioned what is the Fire Authority's Mission Statement, couldn't find it anywhere. What is the cost of the Fire Authority per person per year in the Big Bear Valley?

**Action:** Staff will provide speaker Edward Stanik with the answer to his question, "What is the cost of the Fire Authority per person per year in the Big Bear Valley?"

Director Walsh commented that the form on the RMA to apply for the low-income exemptions in Section 2, should indicate that the person applying for exemption is at or below the very low-income threshold. It currently only stipulates "low-income."

## **COMMITTEE REPORTS**

A Fire Authority Administrative Committee meeting was held on June 19, 2019, represented by Vice Chairman Green, Director Caretto, Director Herrick and Director Ziegler.

Director Herrick reported that the Administrative Committee meeting was accurately reported in the meeting notes.

## **DIRECTORS' CLOSING COMMENTS**

Director Putz encourages anyone in the public who has questions, to contact the Board's Directors or the Fire Chief to get a clear understanding. These are complicated issues and it takes some effort to understand them. There have been some questions tonight that would seem people are mis-informed. There is an opportunity for the public to understand the details.

Director Ziegler fully agrees with Director Putz.

Director Walsh commented that his party affiliation is irrelevant but his is conservative to the point that he wants the public to have the opportunity to have a say.

Director Caretto reported that he attended the California Joint Powers Authority (CJPIA) Annual Meeting on July 17, 2019, representing the Fire Authority, the City of Big Bear Lake and Mountain Transit Agency. The incumbents running for the Executive Board were re-elected. This is not unusual, but one candidate did run opposed. We benefit because one of the council persons on the Board is from Grand Terrace in the Inland Empire. This gives us some input. There were Bylaw's amendments and Joint Powers Agreement amendments, primarily to add a Risk Manager's Committee. They also adopted Bylaw changes that are best practices in accordance with the California Joint Powers Association. There are now 165 members. West Hollywood has been added back. They've added a liability program that makes it more attractive for independent cities like West Hollywood.

Vice Chairman Green asked the Fire Chief if he would be having more meetings in the community for the public to come for updates and ask questions. And, will these be posted on the Department's website? He also commented that he put in an application to be on the California Special Districts Association (CSDA) Board. He filed all the paperwork, but there was a mistake on CSDA's part and did not put his name on the ballot. By the time they figured it out,

it was too late to put his name on the ballot. It is important that we, at the local level have representation. They work a lot on legislation as well. He would have liked to have done that.

Chairman Jahn thanked the Ad Hoc Committee for all the work they have done. He also reemphasized Director Putz' comment stating that we are not at the end of the tunnel, but we are beginning to see the light.
