FA4. Formation of Big Bear Fire Authority Community Facilities District No. 2019-1 (BBFA Fire Suppression and Emergency Services)

Director Putz left the meeting at 5:40 p.m. and returned at 5:43 p.m.

Consultant Andrea Roess responded to a question from a board member.

a. Board consideration of conducting a Public Hearing on the formation of Community Facilities District No. 2019-1 (BBFA Fire Suppression and Emergency Services.

Action: At the hour of 5:56 p.m., Vice Chairman Green opened the public hearing.

Members of the public spoke regarding the formation of a Community Facilities District (CFD).

- Steven Hoppe of Big Bear City stated that he would vote in favor of the CFD but added that he does not believe it will pass. He stated that the Board should not form the CFD until they have a contingency plan to keep the Sugarloaf Station open if the measure fails. Insurance companies are waiting for anything to justify canceling policies. Closing the station and waiting for another year for a vote will not work for insurance companies.
- Bob Ybarra of Sugarloaf stated that he supports the CFD and he believes the community is ready to move forward with the CFD. He is working with a volunteer group that is going door to door sharing the facts and trying to counteract the lies being spread. Volunteers are getting a great response. Offduty firefighters are walking with them after they get off their shift. This community has grown over the past 15 years, yet there has been no increase in staffing. He stated that we need this CFD to support the Department, or this community could be another "Paradise."
- Patrice Duncan of Sugarloaf stated that she is the volunteer coordinator of a grassroots organization called Friends of Big Bear Fire Department that has partnered with Big Bear Professional Firefighters Association. They are also partnering with other agencies to help get the CFD message out. She stated that the CFD is brilliant and shares the burden fairly among residents, visitors and commercial businesses. While walking door to door, volunteers found large support once they were presented with the facts. The biggest challenge they face is the misinformation about the issues.

Action: At the hour of 6:07 p.m., Vice Chairman Green closed the public hearing.

Action: Board Secretary Dawn Marschinke reported that she received 13 protests. No majority protest has been received.

Discussion ensued among Board members regarding the possibility of seeking proposals from alternative service providers to provide fire and paramedic service, or other contingencies for providing service to this community, and moving forward with the CFD in case the CFD fails at the ballot in March. Consideration was given to placing this topic before the Administrative Committee or the Ad Hoc Committee for further discussion.

b. Board consideration of approving Resolution No. BBFA2019-008 establishing the Big Bear Fire Authority Community Facilities District No. 2019-1, and the boundaries thereof, and taking other actions relating thereto.

DIRECTORS' CLOSING COMMENTS

Director Ziegler stated that he met with a top San Bernardino County official. He is concerned about the direction the County is taking in considering eliminating the County Road Commission, the County Park Commission and Berm Removal for the Sugarloaf area. Now our Board is looking at eliminating the local fire department. He does not like the idea of us losing local government and he cannot believe what he heard tonight from the Board and where they are headed. At some point we need to wake up and do the right thing.

Director Putz said that to better understand the San Bernardino County options, he watched the County Board of Supervisor's meeting from last week and read multiple articles in order to understand the financial situation the San Bernardino County Fire Protection District is facing. He was told by a person from the County that they would not want to be part of the County if they were us considering the budget woes they are going through. The County is also considering an additional parcel tax. He stated that it could be a good idea to have a contingency plan but be mindful of not letting that contingency plan get in the way of the current effort we have. These matters move very slowly and that is by design to let the public weigh-in. It is not realistic to think we will have all the answers to these contingency questions in a month or two considering it has taken years to get to this point. He also stated that he did not want a contingency plan to get in the way of what the Department is doing with the CFD. It is not realistic to have an answer to these questions in the limited timeframe we are working with. We need to give the citizens the opportunity to vote for what service they want and what they want to pay for.

Director Oxandaboure stated that what the Department is putting on the ballot is what the community has asked for. That is for the visitors, businesses and ski areas pay their fair share. This is so important. Having been on the Ad Hoc Committee, she believes this is the best option.

Director Caretto thanked everyone who has come out to all these meetings. He knows it is hard to sit through all this discussion.

Director Walsh pointed out that our consultants say that Big Bear is a conservative community and they do not look favorably on the measure passing. He added that he does not want to wake up on the morning of March 4^{th} and not know what our next step is.

Director Herrick stated that he looked forward to the Administrative Committee meeting.

Director Russo stated that he too sat on the Ad Hoc Committee, and after three years of discussion, he believes this is the best way.

Director Jackowski said that the election in March will give the Board a great deal of direction in which way it should be going.

Vice Chairman Green thanked the public and community volunteers and for going door to door to educate residents on the issues. We will continue with outreach and public education. He asked Chief Willis, considering all the insurance cancellations, did the Department's ISO rating change?

Chief Willis responded, no. The Department's public protection class remains the same. The Department moved from a Class 4 to a Class 3 as a result of consolidation. However, insurance companies decided to spread the risk throughout California because of the recent fires in the west. He does not know what the answer is but stated it should be clear if insurance companies are canceling insurance, a logical response should be to increase fire protection and community risk efforts.

Vice Chairman Green further commented that it is not something that we are doing here that is driving insurance prices up. Our ISO rating has come down thanks to the hard work of the fire department which should result in lower rates. Unfortunately, we are tied to other communities across the State. As a result of other devasting fires within the State, insurance companies are spreading the cost.

Director Jackowski stated that he got insurance at a better rate for his new house and does not know what the problem is.

Director Ziegler stated that there is no way he would like to see the East end of the Valley go to County. We have got a choice and he is responsible for what happens on the East end and what they might want to do. If the City of Big Bear Lake ever wants to go their own way, the East end has a say if they want to go to County. They still have the property and buildings.

There being no further business to come before the Fire Authority at this session, Vice Chairman Green adjourned the meeting at 7:01 p.m.
