An Appeal Hearing was held regarding the Notice and Order to Abate a hazardous dead/dying or diseased Tree from the property located at 43134 Sunset Dive, Big Bear Lake, CA APN 2328-632-24-000 issued to the property owner, Tony Mouallem on May 10, 2019. The owner appealed the notice and requested a Hearing before the Big Bear Fire Authority Appeals Board.

Assistant Chief Mike Maltby presented a timeline of actions taken by Fire Authority staff between May 10, 2019 and September 5, 2019 to work with Mr. Mouallem to remove the tree in question.

Mr. Mouallem presented his reasons for appeal based on hardship:

• In the past, the Forest Service took about 10 of his dead trees down and he did not have to pay for their removal. This is the first time the burden has been put on him.

- He was provided with paperwork for grant assistance, but it only covers \$1,000 of the \$4,000 he was quoted for removal by Porter's Firewood.
- He read the arborist's report, but he does not believe it is a hazard because it is freshly dead, and if it falls it will not hit anyone's house but his own.

Mr. Mouallem is requesting more time to have the tree removed.

• Chef Maltby stated that he could give another 30-day extension.
