FA8. Proposed Resolution to Adopt the Fiscal Year 2017-18 Big Bear Fire Authority Budget

Board consideration of conducting a public hearing and approving Resolution No. BBFA2017-004 adopting the Big Bear Fire Authority Budget for Fiscal Year 2017-18.

Chief Willis thanked the staff for all the hard work that went into developing the budget. He reported that staff presented the Board with a planning calendar with a timeline of the work that is planned for the upcoming year through December 2017. This is the work what will be required to develop the FY 2018-19 budget.

Senior Finance Officer Holt presented a recap of the preliminary budget process and an overview of the Department's final budget being presented for approval. At the March 23, 2017, Administrative Committee meeting the draft budgets for all three agencies were presented for review and discussion. Committee input helped in preparation for the full-Board Budget Workshop held on April 19, 2017. Each agency's revenues and expenses were reviewed at the April 19th meeting (as projected from the current year) with the resulting draft budgets and associated assumptions. A three-year overview of the change of fund balance was also presented. At the April 25, 2017, Regular Board meeting the FY 2017-18 budgets were introduced for all three agencies. There are no changes in the budget presented for approval today from the budget presented at the introduction meeting in April.

Director Walsh pointed out the resolution's Operating Expense figure of \$3,308,618 does not match the Budget Flow-Through Worksheet which shows an operating expense of \$3,037,954.

Ms. Holt asked if the resolution could be amended at this time verbally. When read into the record, the revenue and expenses should correct it.

The Board agreed that it could be amended with the corrected number.

Director Walsh stated that the Transfers Out figure for Big Bear Lake Fire Protection District is now short the exact amount of the first SBCERA payment and questioned if there was some change.

Ms. Holt responded.

Director Walsh stated that the fund balance shows a decrease of \$1,077,000, but looking at the reserves of the Fire Authority, it appears the Authority should expect to end the year with \$1,810,000 in the black rather than in the red, and questioned where he should be looking for the \$1,077,000.

Ms. Holt responded.

At the hour of 6:13 p.m., Chairman Putz opened the public hearing. Hearing no public comment, at the hour of 6:13 p.m., Chairman Putz closed the public hearing.

Director Walsh requested that staff not use yellow on the charts. It is very hard to read such as was used on the Vehicle Replacement Schedule.

Director Caretto expressed his objection to the budget and will vote to abstain rather than vote "no" so that the budget can be passed.

- 3. A summary of the outcome from the evaluation will be prepared by the Chairman and sent to all Board members for review and comment in accordance with Brown Act restrictions
- 4. The Chairman and Vice Chairman will meet with the Fire Chief to present the results of the evaluation

Fire Authority Administrative Committee meeting held on March 23, 2017, and May 17, 2017, represented by Board Chairman Putz, Vice Chairman Green, Director Walsh and Director Herrick. May 17, 2017 report was corrected to reflect that Director Caretto was present at the meeting.
