BOARD MEMBER CLOSING COMMENTS.

The Directors extended Happy Holiday wishes to all.

Director Obernolte stated he is impressed with the ability of the ten person Board to come together to work through the issues associated with adopting policies and procedures.

Director Walsh asked Chief Willis if the service areas will be exempt from next year's State Responsibility Area fee (SRA) as the Fire Authority has officially posted its' consolidation, and it should be recognized by the State. Chief Willis advised the Howard Jarvis group is working on this issue, and it may be tied up in the courts for years. Chief Willis stated he will do everything he can to best represent this community and oppose the SRA fee through his efforts in Sacramento as the Legislative Chair for the Fire Districts' Association of California.

Director Terry expressed his pleasure that the Board is able to work together.

Vice Chairman Green wished all a Merry Christmas. He stated he is glad to be part of this history making venture, and in remembrance of the history, would like to see each Director receive a framed fire department patch.

Chairman Caretto stated that based upon past experience with another agency, the Fire Authority adopted the policies fairly well and quickly.

Chairman Caretto commented that he has been reading about the Baldwin Lake Volunteer Fire Department possibly forming a fire protection district. He inquired of Chief Willis whether he has had any conversations with them about how to participate more actively with the Fire Authority. Chief Willis responded that he has had numerous conversations with Chief Winslow and that an easier remedy may be to annex into the CSD for fire protection only.

There being no further business to come before the Fire Authority at this session, Chairman Caretto adjourned the meeting at 8:52 p.m.
